There are very few "good" public venues for large outdoor public concerts, and to destroy one of (perhaps) the best, to create yet another restaurant is an outrage. What is the possible logic behind such a move? Is it to create a special "high-end" eatery for people who have significant wealth, at the expense of the many who live in the area, and do not have significant means. East St Paul is an amazing community, made up of a broad mix of families, ethnicities, and many with limited financial means. We know from anonymous surveys that the make up of our audiences reflects this, especially those with "limited means." Como Park and the Pavilion are a community treasure, and if the city goes ahead with its plan, the local residents will be the losers. There is a serious lack of suitable roller skating facilities in St. Paul, both indoor and outdoor. Trails should be smooth enough to accommodate roller skating, and wide enough to accommodate ski skating. Signage should clearly designate which trail skaters should use - it should be the bicycle trail because skaters shouldn't be mixed with pedestrians. I would also like to see the Como Pavilion opened to roller skating when not in programmed use. This might be a really nice place to put a Pickle Ball court on the edge of the parking lot. Page 32. Transit Stop on Hamline and Como needs a shelter as does transit stops along the curve to Lexington. Solar sidewalk crossing lights should also be included along this stretch to slow traffic. Page 33. Consideration should be made for additional Historic Districts in areas south of Midway Parkway and Warrendale areas. Casiville Bullard actually owned two homes in Como. The other is along Maryland and should also be noted as a Historic Site as he owned land where Como Highschool now is. Page 48. There is no guiding principle regarding art or beautification/maintenance of existing structures. In many locations signage could be incorporated into an ART piece or Decorative Map and make it more interesting. There are many historic topics that could be included to enhance a park experience. Page 54: Nagasaki Rd and E Como Blvd might be a very good place for a Round About to ease traffic conflicts. Page 56: maybe a Round About on the Como Curve at the parking lot/street. Page 58: great ideas to have a path through the golf course. It can also extend to Hamline. Page 60: Wayfinding should also include mileage markers for walking/biking. IE .5 miles to x, 1.3 miles to Y... Page 61: Public Art, there are many ways to include it, but more examples should be presented for comments. Page 62: Conduct Cultural Landscape Study, is that of the park only, or also the surrounding area. It seems many studies have been done regarding the park, but there should be comprehensive studies of the neighborhood of which the park is included. Many of the items on this page should be incorporated even if they were Unranked. So much focus is directly around the lake other area get neglected. Even having a trail within the Como Golf course from Chelsea to the parking lot would make for nice circular traffic options for walkers and bikers within the parks western side. Page 67: Should there be a connection made around Hamline to Energy Park Drive over the railroad tracks as a part of the BNSF Railway possible Aquisition. Pg 68: Historic and Cultural Resources study should be of the neighborhood around the park in addition to the park. There are many studies of what is at the park, but relative to the indigenous history there appeared to be treaty boundaries that went through the neighborhood. Pg 69: Additional technology upgrades are needed in the Street Car station. Possible restroom facilities could possibly added near the street car station.

Como Pavilion Redesign I have enjoyed Como Lake and Park for 13 years, living a block from the lake. Unfortunately I have found the City of St. Paul's management of the Como Pavilion and activities provided in the pavilion and park lacking. The city forcedly replaced Black Bear Crossings Café in 2015 with Como Dockside, a creole themed restaurant which they initially praised, to only have this close

in 2017. Next came the current restaurant, first known as Spring Café, and later rebranded as Dock & Dock & amp; Paddle after new ownership in 2019, both of which continue to receive only mediocre reviews for both its food and service. One must ask how these restaurants and restaurant owners are being selected, and why the City of St. Paul can't secure a good restaurant for the Como Pavilion? On August 17th Pope Architects presented their plans for the rebuild of the Como Pavilion. The new design being proposed is rewarding an under-performing restaurant by giving them 1/3rd of the facility as an open-air seating area, plus another 1/3rd as an indoor restaurant and seating area, then squished the theater stage and seats into the remaining 1/3rd of the pavilion. The need to have viewing of the lake while dining and watching a performance was quoted, yet the proposed layout of the stage will have the audience not facing the lake, but does have the restaurant center stage (pardon the pun) and facing the lake. Pope architects were asked if they knew what the average performance attendance was after quoting a capacity of only 250 people for the new theater, and they said no. How can a community facility designed for community performances be redesigned with zero thought or attention to the performance function of the theater, or attendance levels of the theater? City council president Amy Brendmoen argues that the restaurant is not the issue, it is instead the poor layout of the pavilion that is the issue. I would argue instead that if the city would stop focusing on monetizing the pavilion instead of focusing on building a fun community-based facility, then the pavilion and Como park would thrive. Reading through the long-range plan, most of the communities' comments were about maintenance and safety. For example, repaving of areas of bike paths that are filled with potholes and cracks. I think maintenance and upkeep is often overlooked and detracts from park experience, and should be the main focus of this plan, rather than adding in a bunch of new amenities. This especially applies to the Como Pavilion, which I saw hardly any comments about. This plan downplays/hides the effects of especially redoing the Como Pavilion. If the Como Pavilion is redone according to this plan, the seating for events at the Como Pavilion would decrease from 947 to 225. This would be a huge detractor from people going to the Como Pavilion for events. It would prohibit larger events, such as Rosetown Theatre, Hillcrest Theatre, Twin Cities Jazz Festival concerts, and Operatic performances from being at the Pavilion at all, and would severely the number of the people who could experience music in the parks at all during the summer months. Growing up in the Como Park neighborhood, I attended music in the parks events at least 2-3 times a week all summer long. I don't think my parents would have been able to bring me as often if the pavilion had a smaller seating area, where it would be harder to fit strollers, and easier to be distracted by loud kids. Even now that I am older and no longer live as close to the park, I still make a point to attend multiple concerts and performances at the Como Pavilion all season long. Having a big open covered space for concerts, performances, and events is very unusual in the Twin Cities, and should be celebrated and kept. The Como Pavilion is iconic and beloved as it is, and allows for equity in attending events with it's big open space. A sampling of those that attend music/theatre events at Como Pavilion that would NOT be able to if the space were smaller: People walking by and stopping for just

a half hour on their walk, families with children who may need to move around more or go to the back when listening to music, those with strollers or wheelchairs who need wide open areas to move around, and those with sensory needs who need more space. Not to mention, reducing seating from 947 to 225 would have a HUGE negative impact on community theatre groups and musician/band groups that depend on the size of the Como Pavilion to be able to function in the community and have a space to perform open to all. Minneapolis just repaired and repainted the Lake Harriet Bandshell and added accessible bathrooms, but otherwise kept the bandshell the same with the same amount of seating. This project seems to have been received wonderfully by the community, with much praise and acclaim. The Como Pavilion is the ONLY similar spot in St. Paul, and limiting the number of seating by a factor of 4 would hugely detract from it being used by the community. I'm all for maintaining the Como Pavilion (repairing, repainting) and making more accessible by adding accessible bathrooms for instance, but PLEASE don't take away the big open area or divide it up smaller. The report begins with an acknowledgment to Native peoples, stating "As we consider that the many legacies of violence, displacement, migration, and settlement has brought us to current day, we commit to understanding, respecting, supporting, and advocating for Indigenous People and for this land." If we take this commitment seriously, we should also recall that that the space at the heart of this project, the restaurant at the Como Pavilion, was previously owned and operated by a Native American businessman, David Glass, under the name Black Bear Crossings. We should also recall that he was wrongfully removed from this space in an effort led by then-Councilmember Amy Brendmoen and her partner, Mike Hamm, then-Director of St. Paul Parks and Rec. This process culminated in the loss of one of St. Paul's few Native-owned and operated businesses, alongside an

\$800,000 settlement awarded by the city following a judge's finding of a wrongful breach of contract. It is worth noting that Glass contended that the contract was terminated due to racial discrimination, specifically his unwillingness to comply with CM Brendmoen's recommendations that he reduce the restaurant's Native American decor. I have serious concerns about any report that claims to recognize legacies of violence and displacement of Native Peoples, while at the same time offering no recognition of our own active history of wrongful removal and breached contracts at this very site in question. When we choose to ignore this history -- one which also happens to be extremely relevant to the project proposal in question - we are actively contributing to, and reinforcing this abominable history.

Those seem like great uses of city money to make the park more accessible, as well as to maintain the beautiful natural habitat. I have issues with the pavilion renovation. Apparently, there was a prior survey that addressed the pavilion, but I did not see it when it was advertised (and I do live in District 10 - I'm a Como resident). Thus, I am sharing my thoughts now, and I hope they are considered. To begin, I think making the pavilion more accessible, moving around the bathrooms, and similar changes are appropriate and welcome. My issue comes with the addition of a restaurant and the significant reduction in the size of the stage and audience area. I don't come to a city park to eat at a restaurant; I'm confused as to why that seems to be the focus of the redevelopment. From the plans, it also looks like the new restaurant would be in addition to the food option that is currently there. How silly to reduce space where people can gather and watch the lake (while under cover from sun or other inclement weather), in addition to attending performances (many of which are free), and instead put in a restaurant where people would be forced to spend money. In the past two decades, there's been a rotating list of restaurants that have been in and out of the space that is currently there. Why does the city think a second restaurant will be a stable success? I also am really put off by the fact that the restaurant would be a space where you'd have to PAY to access it. It would be so sad to see a community space turned into something that can only be enjoyed by a select few. The food option that is there now (Dock & Dock & amp; Paddle) is fine, there doesn't need to be more than that. (And even that food is getting more expensive every year, but at least I can walk through that space and utilize the covered outdoor area without having to buy food.) In addition, I'm extremely disappointed that the proposed plans drastically cut the stage/audience space. Performances, like Rosetown Playhouse, will not be able to be staged anymore. I go every summer to see those performances-- and they are consistently packed. I've gone to free showings there as well; also heavily attended. The covered stage is a space that is

being used and enjoyed. When performances are not being held, it is a space in which people can spread out, relax, and watch the water. It serves so many purposes. Why that would be reduced (to, again, make room for a restaurant) is baffling to me. I've also seen justifications for moving the stage (and thus reducing its size/seating area) based on the fact that under the current set-up, the audience can't see the lake. Well, when I'm watching a performance, I'm watching the performance. When it's done, I can just turn around and voila, the lake! I've never thought to myself "I wish I could see the lake" when I attended a show. So many of the long-range plan's projects seem worthy -- they make spaces more accessible, safer, and resilient to climate change or other environmental factors.
