 - Looking back through 3 years of ADA complaint data
 - Building off the City of Saint Paul's pedestrian priority plan

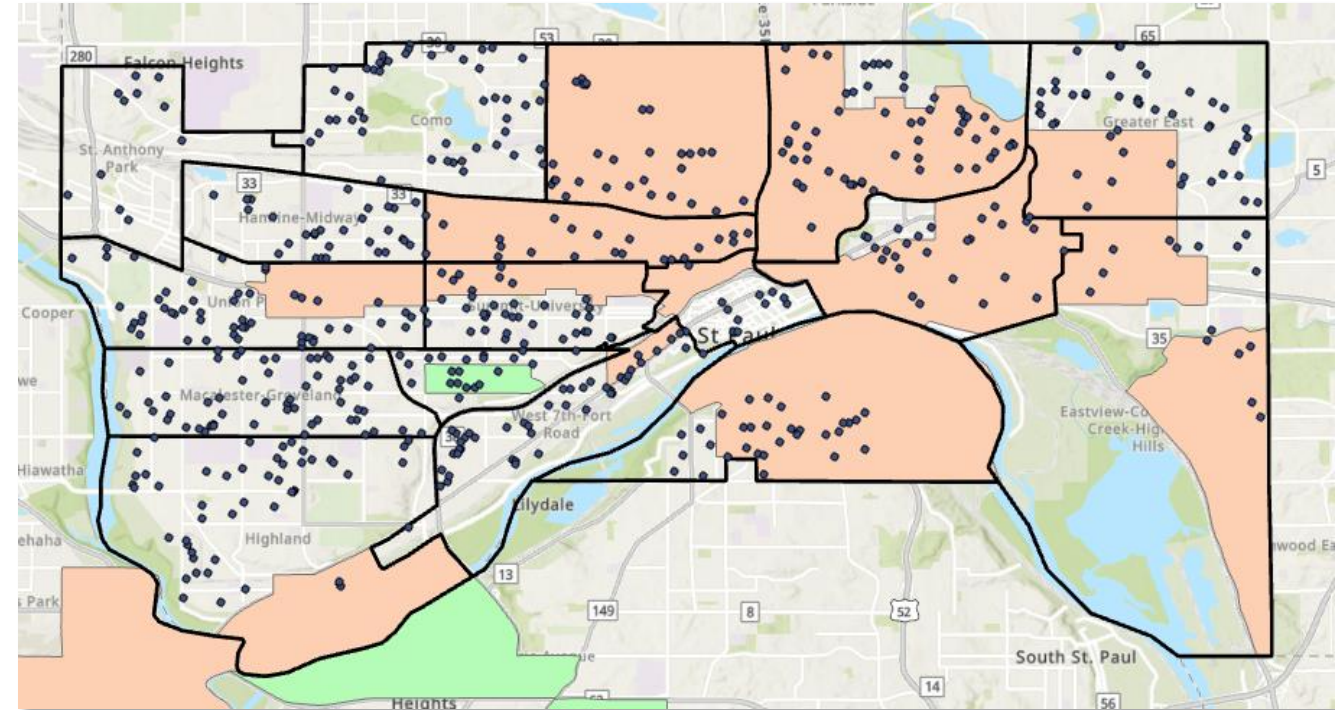
Priority = Accessibility + Equity

Equity Approach: Engagement

- We are looking at:
 - Complaints per capita
 - Complaints in high pedestrian priority areas
 - Percentage of diversity compared to citywide demographics
 - Disability status
 - Concentrated poverty and affluence
 - And others...
 - What are we missing?
- This will inform:
 - Where we focus our engagement efforts and target communities in pedestrian priority areas but with lower complaints per capita

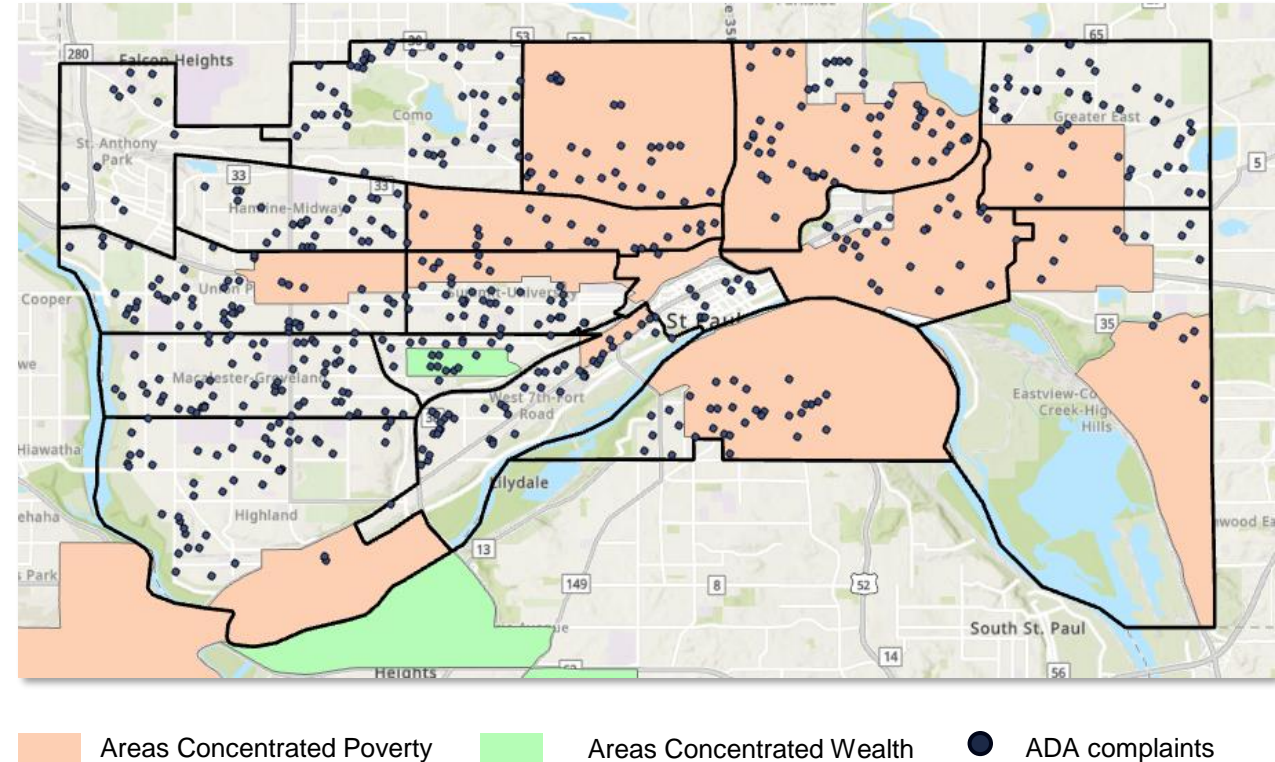


Areas Concentrated Poverty Areas Concentrated Wealth ADA complaints

 - Equity scores that will accompany the ADA Field evaluation and prioritization

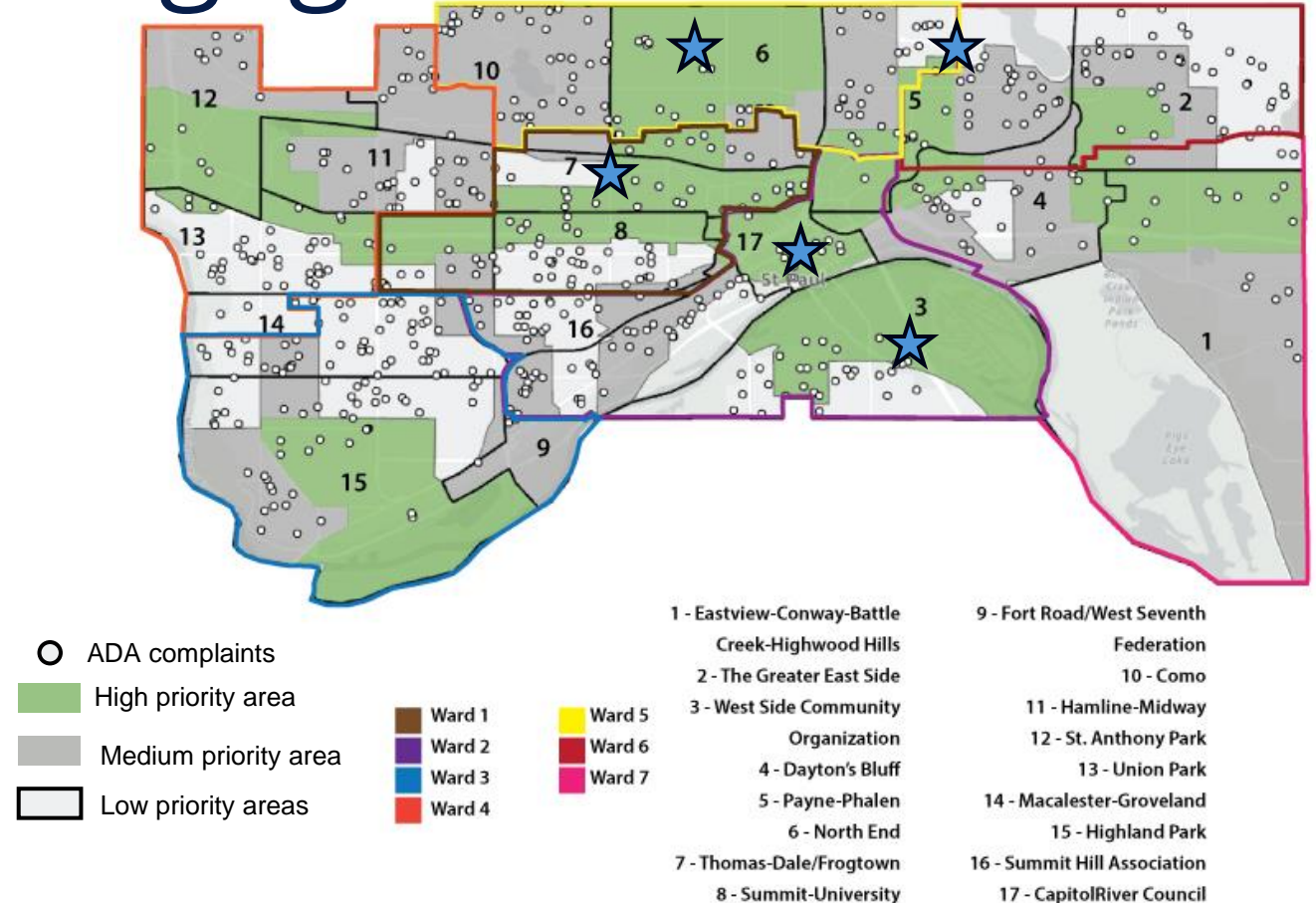

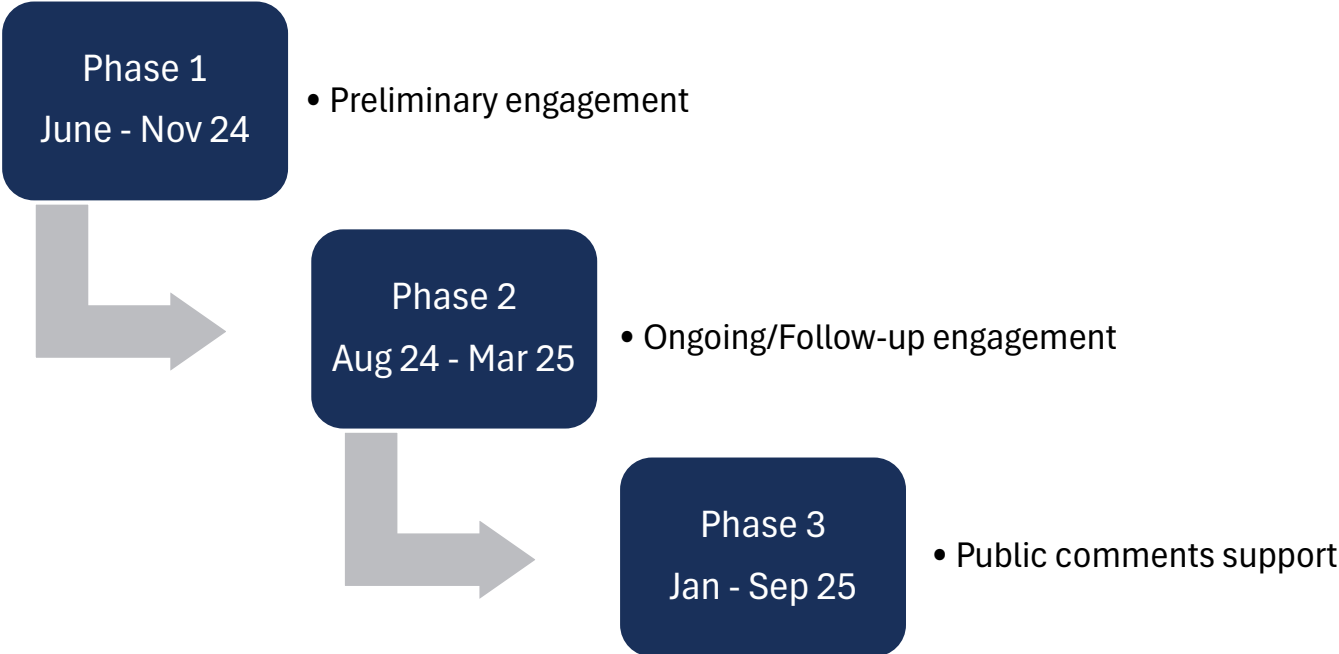
