BENEFITS

Plumbers do not receive City benefits. Employer contributions are made on behalf of employees for union-provided fringe benefits. Rates include the taxable Credit Union deduction of \$7.87 (Apprentice Plumbers – varies by year and when indentured – see salary schedule for taxable credit union vacation contribution.) New employees do not participate in PERA.

Grade 001 – All W/O PERA rates – Temporary employees are ineligible for PERA.

All Other Grades:

Step 01 – W/PERA rate for Certified employees grandfathered in PERA.

Step 02 – W/O PERA rate for Certified and Temporary employees.

PREMIUM

Master of Record: An additional \$0.50 per hour premium shall be paid to the individual in each department designated as the Master of Record. The Employer retains the exclusive right to select that individual; however, the employee must agree to be designated.
