- I. Call to Order at 5:03 pm by Chair Dees Erickson Roll Call

- IV. Budget Amendments Additional Information- Contingency
 - a. Anne Weber from Public Works presented the following budget amendments:
 - a. **Public Works RES PH 25-21 6th/Kennard Pedestrian Improvement \$285K:** *Adding* \$55,000 STAR funding to the 2023 Traffic and Pedestrian Safety Program for the 6th/Kennard Project. Adding \$230,000 STAR funding to the West Side Pedestrian Improvement Project. Discussion followed. O'Brien moved and Braun seconded to recommend approval of the motion. Motion passed.
 - b. Public Works RES PH 25-22 Lighting Improvements and 2021 Wabasha \$750K: Adding \$500,000 Ramsey County funding to the 2025 Lighting Improvements Program, transferring \$500,000 MSA to the 2025 Lighting Improvements Program and \$250,000 MSA to the Kellogg-3rd Bridge Project from the 2023 Wabasha Signal Project. Discussion followed. Pang moved and Cox seconded to recommend approval of the motion. Motion passed.
 - c. **Public Works RES PH 25-28 Contingency Budget Transfer for Dale St Campus \$177K:** *Amending the financing and spending plans in the Department of Public Works Capital and Capital Maintenance Contingency Budgets to transfer funds for the Dale Street Campus Improvements.* Discussion followed. Dees-Erickson inquired if CIB could get project updates including budget to actuals for Dale Street Improvements. Hess moved and Braun seconded to recommend approval of the motion. Motion passed.
 - b. Alice Messer from Parks and Rec presented the following budget amendment:

- i. **Parks RES PH 25-23 Met Council Parks and Trails Legacy Funds \$3,151,341:** *To establish the financing and spending budgets in the Department of Parks and Recreation in the total amount of \$3,151,341 for the 2025 Metropolitan Council Parks and Trails Legacy funds for projects including the Harriet Island Long Range Plan, Hidden Falls Crosby Farm Regional Park Long Range Plan Implementation Phase III, Long Term Vegetation Maintenance, Lower Landing Improvements, Phalen Activity Center Design, Point Douglas Regional Trail Phase I Design, Samuel Morgan Regional Trail Segments 1 and 4 Design, the Como Shuttle, Great River Passage and Volunteer & Education Coordinators.* Discussion followed. Tolbolt moved and O'Brien seconded to recommend approval of the motion. Motion passed.
 - c. Molly Lunaris and Dan Niziolek from the Department of Safety and Inspection presented the following budget amendment:
- DSI RES PH 25-25 2025 Animal Services Building Project \$5,731,475: Amending the i. financing and spending plans in the Department of Safety and Inspections capital maintenance project budget and contingency funding to establish the 2025 Animal Services Building Project. Discussion followed. Lunaris explained that DSI deferred maintenance projects in a deteriorating building, based on the advisement of Real Estate division. They recommend DSI take over a nearby building and make improvements to that building instead. Parks and Recs owns the building in which DSI would move these operations for a 6 to 10 year time horizon. DSI would use the funding to fix long term issues in the building. Committee discussed the project needing considerable contingency funding for a 6 to 10 year term which they debated whether that was a sustainable practice. The Committee asked again for a budget to actual report of CIB projects that had been approved but had not made any spending progress (as had occurred in this case). The Committee discussed whether departments should be required to spend a minimum on maintenance to ensure that department facilities are being updated as planned and budgeted for. O'Brien moved and Johnson seconded to recommend approval of the motion. Motion passed.

Authorizing the Department of Parks and Recreation to amend the financing and spending plan in the amount of \$125,000 and to enter into a grant agreement with the Metropolitan Council to accept fishing pier grant funds, which includes an indemnification clause.

WHEREAS, RES 24-1834 authorized the Department of Parks and Recreation ("Department") to apply for funds from the Metropolitan Council's fishing pier construction grant program to construct a new fishing pier at Crosby Farm Regional Park; and

WHEREAS, the Department was awarded \$125,000 for the project; and

WHEREAS, the Department wishes to enter into a grant agreement to accept said grant funds and establish a financing and spending plan for said grant; and

WHEREAS, the City Council finds that there is a public purpose in providing public park amenities that encourage outdoor recreation; and

WHEREAS, the Mayor, pursuant to Section 10.07.1 of the Charter of the City of Saint Paul, does certify that there are available for appropriation funds of \$125,000 in excess of those estimated in the 2025 capital improvement budget; now, therefore, be it

RESOLVED, that, upon the recommendation of the Mayor, and the advice of the Long Range Capital Improvement Budget Committee, that \$125,000 is available for appropriation in the 2025 capital improvement budget, and said budget, as heretofore adopted by Council, is hereby further amended as outlined in the attached Financial Analysis; and, be it

FURTHER RESOLVED, that the City Council authorizes the appropriate City officials to enter into an agreement with the Metropolitan Council for the aforementioned funding, which includes an indemnification clause.
