




Phase 1 to begin construction in early summer of 2025, to be completed by November of 2025.

Project Improvements

- New concrete curb and gutter
- New roadway pavement
- Utility upgrades including new watermain, storm and sanitary sewer mains.
- Sidewalk replacement and new sidewalks where none exist
- ADA-compliant pedestrian ramps
- Lantern style Street Lighting
- Tree Planting




- Engineering staff analyzed the survey data of existing topographic conditions and have made revised recommendations for placement of new sidewalk within the project area.
- Current proposal follows existing Sidewalk Policy.
- Recommendations for new sidewalk on one side only for Parkview, Ivy, Orange and E. Como Boulevard.
- Recommendations for sidewalk on both sides of Osage, Avon and Folsom.
- Existing walks on Osage, Ivy, Avon and Folsom will be replaced to address non-ADA compliance, damaged or tree heaved panels.






WHEELOCK/GROTTO PHASE 1 - PARKVIEW






WHEELOCK/GROTTO PHASE 1 - IVY






WHEELOCK/GROTTO PHASE 1 – ORANGE ST.






WHEELOCK/GROTTO PHASE 1 – E. COMO BLVD.






WHEELOCK/GROTTO PHASE 1 – OSAGE ST.






- Public Works Sewers sent out sanitary service replacement waivers to residents – February 4, 2025

Curb Cut Boulevard Rain Garden Grants



Street reconstruction is an excellent time to add rain gardens to treat polluted street runoff.

CRWD partners with City of St. Paul to design and construct of curb cut boulevard rain gardens during road work, residents maintain the garden.
